Part III – Statement of Program Service Accomplishments

Mission

To protect the wildlife, wild places, and community character of Jackson Hole.

Organizational Overview

For four decades the Jackson Hole Conservation Alliance has worked to protect the wildlife, wild places, and community character of Jackson Hole.

In Fiscal Year 2020 (FY20) the Alliance worked to empower our community to become a national model of living in balance with nature. To create a better future, we integrate focused issue advocacy campaigns, intentional base building, leadership development, targeted education efforts, and accountability work.

Accomplishments & Milestones: FY20

Funded Wildlife Crossings through SPET

We've spent 10 years working with volunteers, neighbors, and partners to build community support for wildlife crossings. We succeeded in getting the town and county to include wildlife crossings on the November SPET (Specific Purpose Excise Tax) ballot, then worked vigorously to get out the vote and ensure the measure passed – with almost 80% of the votes!

Raised the Community Voice for a Balanced Snow King

We want Snow King to succeed as our Town Hill, not an amusement park. We wrote letters, made videos, and kept a watchful eye on the Forest Service and town approval process. We're grateful that the Town Council did not rubberstamp the developers' massive proposal to the Forest Service.

Graduated another round of new leaders

Another 16 participants went through Round 10 of the Conservation Leadership Institute (CLI) and learned how to make a difference in our community. There are now 140 total CLI graduates. During the 12-week course and beyond, this class moved the needle on local issues including the plastic bag ban, wildlife crossings, and the Genevieve block.

Saved the Genevieve Block

When a group of women from CLI heard rumors of hotel development on the Café Genevieve block, they took on the issue as their team project. They went to public meetings, met with local elected representatives, organized informational rallies, and opened the floodgates for an outpouring of community support. This prevented a hotel-focused upzone and paved the way for the Jackson Hole Land Trust's successful fundraising effort to protect the block forever.

Don't Poach the Powder

Last winter, we teamed up with coalition partners to spread the word about the need for responsible backcountry recreation. We recruited passionate volunteers, gave out stickers at trailheads, shared information at the Wyoming Snow and Avalanche Workshop (WYSAW), and discussed bighorn sheep habitat at Avalanche Safety Night.

Formed Bear Proof Trash Can plan

Following a robust report put together by intern Emma Leither in summer 2018, we have worked toward implementing bear proof trash can policies in Teton County. We presented research findings to the Natural Resource Protections committee, met with local representatives to discuss feasibility, and built a campaign plan to move this project forward.

Housing mitigation

We spoke up for housing, and successfully saw the town and county adopt increased housing mitigation requirements on commercial development. We believe that protecting what we love about this place requires a strong community, which means a diverse group of committed residents is able to live here long-term.

Launched accountability checks and first 'vote round-up'

It can be a challenge to get involved and make a difference if you aren't "in the weeds" of local politics every day. So, we launched Alliance Accountability Checks - including voter guides, newspaper ads, and our Conservation Vote Round-Up – all highlighting local and state elected representatives' decisions on key conservation issues.

Hired a Community Planner

Since our founding as the Jackson Hole Alliance for Responsible Planning 40 years ago, our staff and volunteers have profoundly influenced the way that Jackson Hole has (and hasn't) developed. Since we haven't had a dedicated planner on staff for two years, we held a fundraising campaign this year to bring it back. Thanks to generous supporters, we succeeded in securing three years of funding and hired Brooke Sausser as our Community Planning Manager.

Celebrated our 40th anniversary

We dug deep to celebrate our 40th anniversary as an organization. We read decades of articles, interviewed longtime supporters, and reconnected with former board members. We compiled our history and made an anniversary film to tell the story of who we are, which is now available on our website. We felt 40 years of passion and community during our Annual Meeting Story Slam in June and 40th Anniversary Party in August. And we partnered with the art community to compile and auction off the "Conservation Collection." We are grateful to everyone who is a part of our past, present, and future!

Part IV – Supplemental Information

Alliance staff both directly met with and organized our members and supporters (through emails and social media appeals) to meet with local legislators and government officials regarding a range of local issues like updates to Town and County land development regulations (including new natural resource regulations, Town residential regulations, Town & County affordable housing requirements on new development, and rural zoning amendments), funding to implement the wildlife crossings master plan, Snow King resort development, and other community planning and conservation-related matters.

NOTE: In some cases, these discussions were educational (not lobbying) in nature, as specific legislation had not yet been prepared or considered.

We also directly met with and organized members to meet with state legislators regarding a range of locally-relevant issues including multiple bills to take away local decision-making (fencing regulations, private school zoning, housing, and subdivisions) and a proposed “Public Lands Day” bill during the legislative session.

This year, we led a significant direct lobbying effort asking Teton County voters to support a \$10M safe wildlife crossings funding measure. This measure passed with almost 80% voter support. Our direct lobbying included door-to-door and phone canvassing and a communications campaign, coordinated with partners in a local Political Action Committee.
