Mission

Protecting the wildlife, wild places, and community character of Jackson Hole.

Vision

Jackson Hole is a national model of a strong community living in balance with nature.

Organizational Overview

40 years ago, a group of caring neighbors bound by a ferocious love for the magic of Jackson Hole founded the Jackson Hole Alliance for Responsible Planning. We've worked as a watchdog to defend Jackson Hole from many things you don't see today, from oil/gas wells in Cache Creek to a dam that would have flooded Oxbow Bend, and much more. Now, as the Jackson Hole Conservation Alliance, we believe our valley still needs a local organization with deep roots to address bad ideas that don't align with our community's values. And we believe that if we are to succeed in protecting the wildlife, wild places, and community character of Jackson Hole, we must do more than respond to threats: we must empower the whole community to proactively create a better future.

That's why we work to make Jackson Hole a national model of a strong community living in balance with nature. This is a future for Jackson Hole where abundant populations of wildlife have the freedom to roam across the landscape, through our neighborhoods, and safely cross our roads; where we live in walkable neighborhoods with accessible transportation choices and affordable homes, surrounded by protected open space, working agricultural lands, and connected wildlife habitat; and where we respect wildlife when we recreate on protected, wild, well-managed public lands.

To create this better future, we integrate focused issue advocacy campaigns, intentional base building, leadership development, targeted education efforts, and accountability work.

Accomplishments & Milestones: FY21

Followed through on Wildlife Crossings funding

In 2019, we succeeded in getting the town and county to include wildlife crossings on the November SPET (Specific Purpose Excise Tax) ballot, then worked vigorously to get out the vote and ensure the measure passed – with almost 80% of the votes! This year, we worked with Teton County Engineering and local partners to prepare for the first crossing structure installation at the Hwy 22 / Hwy 390 intersection – the top priority in the Wildlife Crossings Master Plan.

Raised the community voice for a balanced Snow King

We want the Snow King ski area to succeed as our Town Hill, not an amusement park. We lobbied Town Council and engaged in the United States Forest Service environmental impact statement process. As a result of our work, we prevented a zipline from the summit to the base, a gondola base bifurcating the town ballfield, a permanent wedding venue on the summit, and eBikes on the trails. And we kept multiple harmful projects on hold until a future "Phase 2," including major clearcutting in Northern Goshawk habitat, an additional 15,000 square feet of summit development, and development in winter elk range in Leeks Canyon.

Prevented a massive upzone in Northern South Park

We faced another unexpected proposal from landowners south of town, this time asking for a 300-unit zoning increase on their ranch land. Local realtors estimated that the homes pitched as “workforce” housing would cost \$1.2-1.9M – far out of reach of most of our essential workers. We worked with partners in conservation, water quality, and housing to ensure that the County Commission heard from our whole community, not just the developers’ PR firm. We were successful, and the County Commission said “no” to the upzone and “yes” to a more holistic neighborhood plan – now underway.

Graduated another round of new leaders

Another 15 participants went through Round 11 of the Conservation Leadership Institute (CLI) and learned how to make a difference in our community. There are now 172 total CLI graduates. During the 12-week course and beyond, this class moved the needle on local issues related to the climate crisis including transportation, water quality, and housing that local workers can afford.

Don’t Poach the Powder

With increased staff capacity this winter, we updated our outreach materials for our educational “Don’t Poach the Powder” campaign. This includes a brand-new brochure with the interactive winter range map created in partnership with the Teton Conservation District, as well as Don’t Poach the Powder Gogglesocs, a stylish accessory that protects your ski goggles and reminds fellow skiers to “KNOW BEFORE YOU GO!” We also held two successful events – a virtual “Picnic Briefing” and a tabling event at Cache Creek – and we welcomed an Americorps Member to help with content creation, program development, and progress reporting.

Bear-Proof Trash Cans

We worked with non-profit, county, and business partners to begin a natural resource Land Development Regulation (LDR) draft update, which would increase the current bear conflict area to county-wide. We collaborated with the Integrated Solid Waste and Recycling team to draft a strategic multiyear phase out plan complete with funding options and a scaled pay-as-you-throw program. We are now working with the planning commission to bring the updated LDR’s to the Board of County Commissioners and rally the community in support of its approval.

Heli-No

After large community outcry in 2019, The Alliance, along with the National Parks Conservation Association (NPCA), once again rallied the community in 2020 in opposition to commercial helicopter tours in Jackson Hole. This led both the Town of Jackson and the County Commission to unanimously pass resolutions banning commercial helicopter tours over Grand Teton National Park and surrounding public lands. We helped facilitate a coalition made up of a diverse group of influential stakeholders, who in 2021 will work to move these symbolic resolutions to the Wyoming congressional delegation and into federal legislation, banning all commercial air tours in Grand Teton National Park.

Comprehensive Plan Update

In 2012, Teton County adopted a comprehensive land use plan with the vision to “protect and preserve the area’s ecosystem.” Recent residential growth triggered an automatic update process, a chance to pause and reassess. The update was a bit like Pandora’s Box – with the power to change our community for the better, or the worse. We rallied the community to ask for new and sweeping water quality improvements, to explicitly confirm residential and commercial growth limits, to add a new chapter on climate action, and to hire a staff ecologist in local government – with significant success.

Housing mitigation

Last year, a group of landowners and developers tried to get the state legislature to overturn local rules requiring developers to provide housing for a small percentage of new employees. Although the bill failed, the increased pressure from Cheyenne prompted local government to preemptively and arbitrarily slash required rates. We pushed back against the steepest of cuts and prevented the worst-case outcome. We are stakeholders in a Housing Nexus Study and Needs Assessment that will help determine the range of appropriate mitigation rates. We believe that protecting what we love about this place requires a strong community, which means a diverse group of committed residents is able to live here long-term.

Continued accountability checks and ‘vote round-ups’

It can be a challenge to get involved and make a difference if you aren’t “in the weeds” of local politics every day. This year we published our second annual Alliance Accountability Check – including voter guides, newspaper ads, and our Conservation Vote Round-Up – all highlighting local and state elected representatives’ decisions on key conservation issues.

Hired a new Conservation Program Manager

After two years without a dedicated conservation staff position, we held a fundraising campaign to bring it back. Thanks to generous supporters, we succeeded in securing three years of funding and hired Chelsea Carson as our Addie & Ted Donnan Memorial Conservation Program Manager.

Alliance staff both directly met with and organized our members and supporters (through emails and social media appeals) to meet with local legislators and government officials regarding a range of local issues like updates to Town and County land development regulations (including new natural resource regulations, Town residential regulations, Town & County affordable housing requirements on new development, and rural zoning amendments), implementation of the wildlife crossings master plan, Snow King resort development, and other community planning and conservation-related matters.

NOTE: In some cases, these discussions were educational (not lobbying) in nature, as specific legislation had not yet been prepared or considered.

We also directly met with and organized members to meet with state legislators regarding a range of locally-relevant issues including a state land transfer bill and multiple bills to take away local decision-making, during the remote legislative session.
